The Distillery will offer tours and customer experiences, approximately 15 a week. These will be pre-booked, and will take place typically between 12.00pm and 7.00pm, Thursday to Sunday. During these tours and experiences customers will be able to purchase alcohol for consumption on and off the premises 3. In addition, when the Distillery is open customers will be able to walk in and purchase alcohol for consumption off the premises, subject to normal checks to ensure they are of legal age 4. The Distillery will also offer trade and corporate events where alcohol will be consumed, however they will not be accessible to the general public 5. The Distillery will be open for walk in customers to come in and consume alcohol on the premises, during a very limited range of opening hours. We will extend these hours to late evening by exception, for example during large events such as Lumiere and in the Christmas and New Year period. This will be no more than 10 times a year. 6. We will operate a mail order service from the Distillery. This will be very limited in operation (we have outsourced the majority of our mail order customer deliveries to Amazon) 7. We will make deliveries to trade customers from the Distillery. On very rare occasions this may involve deliveries to domestic premises, however this is very rare. The products we sell are very high end spirits. We are not operating a dial a drink service

		<p>Sale of alcohol (on and off) Monday to Sunday 24 hours daily to allow for deliveries</p> <p>We make deliveries to trade premises as part of the normal operation of the Distillery. These can vary from a couple of cases up to several pallets. There are a small number of occasions when we make a delivery to a domestic or residential premises. This is a tiny number per year. This is because there are a number of premises in Durham which are licensed and also residential - for example Durham University Colleges. This is a rare occasion and we do not allow individuals who are not trade customers to purchase alcohol for delivery.</p>
